#### STUDENT COMMITMENT AGREEMENT

Participate in sexual contact or sexual activity.

Travel anywhere without their host/sponsor family. Any other travel may be done with clearance from the school administration.

Participate in sky diving, hang gliding, parachute jumping or any other dangerous activities.
