

HOMESCHOOL PROGRAM OVERVIEW

2025 - 2026



Enrollment in FCA Homeschool is open to all Christian homeschooling families **who** believe in the Lordship of Jesus Christ and are in agreement with the doctrinal statements of Faith Christian Academy.

The homeschool year is based on 175 calendar days of school and runs from August 1st - May 30th. Parents should be mindful of this when scheduling and completing courses in a timely manner.



BASIC HOMESCHOOL PROGRAM

- Record Keeping **thru grades, transcripts & monthly reports**

Compliance with the State of Florida Statutes

Standardized Testing (required)

- Kindergarten - 7th Grade: MAP 8th
- Grade: PSAT 8/9
- 9th - 10th Grade: PSAT **NMSQT**
- 11th - 12th: **school day** SAT, or ACT

Parents meet with Homeschool Coordinator

- to complete their student's Action Plan **to discuss** subjects, electives, curriculum, etc.
- Assistance with choosing curriculum Portfolio evaluations for any class not being taken on FLVS Flex- due upon submission of final grades on or before June 1st
- Parent meetings (as needed)
- Eligible to enroll in various afterschool sports.
- Secondary sports are on a tryout basis. (additional fees apply)

FINANCIAL RESPONSIBILITIES

All students who attend Faith Christian Academy **will** meet with the **Homeschool Co-ordinator**, to make payment arrangements during **the action Plan meeting**. Enrollment will not be finalized until all financial obligations are complete.



STUDENT CONDUCT & EXPECTATIONS

Students who are enrolled as part of the homeschooling program at FCA are expected to follow the policies listed in the **FAITH CHRISTIAN ACADEMY PARENT/STUDENT HANDBOOK** while on and off the school campus. Any student who participates in a school sponsored event (i.e. sports, clubs, and/or trips) is still a representative of FCA and must model and demonstrate the standards of moral conduct. Homeschool students are no exception.

MONTHLY REPORTS DUE THE 5TH OF EVERY MONTH

Monthly reports for homeschool students are **required** to be submitted. The Homeschool Coordinator will send a reminder each month. The form is located on FCA's website and is submitted electronically. **This form is required should the homeschool program be audited for student progression.**

There will be a **\$30** late fee per child for all reports turned in after the 5th of each month.

PORTFOLIO EVALUATION FOR NON-FLVS CLASSES

All families enrolled in non-FLVS classes in kindergarten through 12th grade will need to submit a portfolio **to** the Homeschool Coordinator. The family will need to demonstrate consistent progress on skills and content material related to the child/children's current grade level. The portfolio is a measurement of student progress and will be the property of the family. The homeschool coordinator will guide, assist, and evaluate a student's portfolio yearly (more often if needed). Florida Virtual Classes do not need to be included in the portfolio. Portfolios should include copies of: all monthly reports, all tests

and quizzes, as well as at least 20 work samples (10 per semester, taken throughout the year) for each subject (non FCA/FLVS courses only).

The homeschool coordinator will review each 12th grade student's coursework to ensure that he/she has completed his/her coursework for the academic year/graduation.

For Bible credit, a portfolio submission is required. This will be discussed during the Action Plan meeting.

9TH - 12TH GRADE OPTIONS



DUAL ENROLLMENT (DE)

Effective June 30, 2019

Homeschool students may enroll in dual enrollment courses the summer after their 10th grade year. Students may take up to 4 courses per year: one course first semester, one course second semester, and two courses during the summer. **Dual enrollment is dependent on GPA and PERT score.**



HONORS COURSE VERIFICATION

In order to receive honors credit (middle and high school only) for an honors course taught by a certified teacher (not the parent), the student must present the syllabus, a brief bio of the instructor, and 40% of graded assignments and assessments to the homeschool coordinator. A FCA honors teacher (subject appropriate) will review the material and determine if the student will receive honors or college prep credit for the course.

The enrollment fee is due when the family has been accepted and non-refundable.

MONTHLY REPORTS DUE THE 5TH OF EVERY MONTH

Reports are submitted electronically. There will be a \$30 late fee per child for all reports turned in after the 5th of each month. The second consecutive month late will result in a \$35 per child fee and probation. The 3rd consecutive month late will result in withdrawal from the FCA Homeschool Program. There will be a \$100 Reinstatement Fee for students withdrawn due to late submission of reports.
